## BACKGROUND

Firstan Ltd is producing over 500 million cartons each year to the pharmaceutical, healthcare, cosmetic and food retail industry sectors and required a solution to improve its order management and Accounts Payable (AP) functions.

In the past, orders were received by either email, fax or postal mail which were then processed manually into the system by sales order processing (SOP) and AP representatives. Therefore these paper-based documents could potentially be lost in transit and the information that was being keyed in manually could often lead to delays and errors causing customer queries further down the process.

However, the biggest challenge for Firstan was to find a solution that was compatible with its existing order management and accounting systems, EFI Radius and Sage.

### SOLUTION

Firstan made the decision to select a solution that could replace its current process but be easily implemented into its existing systems and ultimately streamline order management through end-to-end automation.

Esker could commit to the requirement that Firstan had for the solution to be up and running within a matter of days/weeks not months. Also the end users could be fully trained in this timeframe due to the solution having a flexible platform which would then allow Firstan to continue to manage the process themselves.
